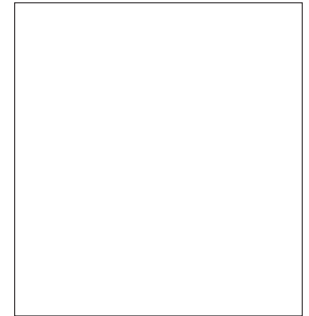

**TERMS & CONDITIONS FOR ICRI STUDENTS**

1. I \_\_\_\_\_ S/O \_\_\_\_\_ R/O \_\_\_\_\_ specifically undertake to accept and agree to be bound by these terms & conditions hereunder and all the other terms & conditions as detailed in the application form, student handbook, rules & regulations of ICRI /Institute of Clinical Research (India), which have been read and understood by me and acknowledged hereby by signing these terms & conditions.
2. I understand that this Certificate program is a Mixed-mode program with electronic-assisted delivery. I understand that lectures will be in presentation form and can be downloaded alongwith other material from ICRI's website. Contact classes are limited to as prescribed in the syllabus only.
3. I also understand that no physical study material or books are provided by the Institute and that access to computer and Internet is essential to effectively undergo this program as all the study material, presentations and assignments are available and accessible on the Internet.
4. I am aware that I will have to physically and personally visit ICRI campus to appear for written examinations.
5. I also acknowledge that the institute has spent a substantial money in terms of Administrative, Accounting cost which the institute is entitled to recover/deduct from the payable/fee paid by me, even if I withdraw from the course without completing.
6. I have seen and read over the course content and am fully satisfied, however I agree that the Institute reserves the right to change, amend, add, alter, vary, modify and/or delete the same at any stage of the course as it may deem proper and I shall not have any claim, grievance, right and demand in this regard.
7. I understand that in case of violation, indiscipline or cheating in the examination etc the institute shall have the right to rusticate, terminate or prevent me from appearing or attending any class or exam or I may be asked to repeat the exam or to present for re- registration as a student. This action may be taken by the Principal or any authorized person under the ground of indiscipline or poor academic performance.
8. That since I have been duly registered with the Institute by signing of these terms & conditions and the Institute on account thereof has reserved a seat which the institute will not allocate to any other student and the Institute will have to incur costs including the fixed costs and administrative salaries and other fixed expenses which it will not be able to recover in case I after registration desire to withdraw/discontinue from the course for any reason whatsoever and as such the institution will suffer a loss and therefore I shall not be entitled to any refund under any circumstances.
9. I agree that all fees are subject to change without notice at the discretion of the management of the Institute, without assigning any reason whatsoever. Taxes levied by any government body will be additional over and above the fees charged.
10. In case the cheque is dishonored by the bank due to any reason, I will be liable to pay a sum of Rs. 1,000 as processing charges along with a fine of Rs. 1000 per day as late fee from the date of intimation of the dishonor of the cheque. If a cheque, issued on my behalf, is dishonored more than once, any time during the course, I shall be required to deposit the balance fee in one single installment.
11. I understand that 'Certificate in Patient Care & Customer Services' and 'Certificate in Medical Tourism' programmes are awarded by ICRI and are not recognized by AICTE/ UGC or any other State Act.
12. I further agree that the medium of instruction and all correspondence between me and the institute shall be in English.
13. That the present course is being offered by the Institute on the basis of the present government policies (including Local/State/Central Government), rules & regulations, notifications, enactment. Any loss/damage due to closure or disruption of the activities of the Institute or the conducting of courses of the Institute caused by any industrial action, government action, fire, flood, riot, natural calamity, change of law & regulation force majeure, terrorist activity or for any other reason whatsoever beyond or not in the control of the Institute which disentitle the Institute from offering the said course, no amount of fee will be refundable, nor shall the Institute or its personnel be liable in any manner nor shall they be liable to pay, in anyway, any compensation to the student.

In case of any adverse government policies on the course being offered, through Acts of Parliament, State Legislation, Local Government bodies of India or any other body in the world which may lead to the effect the awarding of the diploma, the institute will not be responsible and no refund of any sort will be applicable in such instances. The jurisdiction of this agreement will be heard only in the court of law in the city of Delhi.
15. The Institute will not be responsible in anyway whatsoever for the performance of the student in any examination, interview/job/extra-curricular activities, etc. The Institute is also not responsible in anyway for ensuring job/placement of any nature whatsoever.
16. I understand the Institute does not take responsibility of giving a job or placement to a student
17. Examination are conducted on specific dates and if candidate misses any exam, he will have to wait till the next examination date and pay Examination fee, currently Rs. 1,000/- or as prescribed at the time.
18. The institute's program is based on skills enhancement and since the program duration is of 3 months, it does not fall under the purview of UGC/AICTE or any state act.
19. I understand that I have approached Institute for admission at Delhi / Mumbai / Bangalore/ Ahmedabad/ Hyderabad/ Dehradun and have agreed to attend contact classes at the said place and unless the said place is changed in terms of these terms & conditions, I will be attending classes at the said place.
20. I understand that the Institute at present is operating from its current venue. The same venue is likely to be continued during the entire course for which I have joined. However, I shall not have any claim, right and interest to continue at the same venue throughout the currency of the course or to write examination at the said center and Institute shall have the right to shift the venue to any other location without assigning any reason whatsoever to me. However if the venue for conduct of examination is shifted for any reason whatsoever, I shall not be paid any refund and shall have to appear on my own at the shifted venue and at my own cost. I, in no circumstances will be entitled to claim refund of fee for the period which I have already undergone studies at the Institute.
21. This agreement is being completed by the signing of the same by the officials at Delhi and therefore, it is mutually agreed that courts at Delhi shall alone have jurisdiction to try and entertain any dispute arising and/or concerning this agreement.

These Terms & Conditions embody the entire contract between the parties hereto and the parties declare that in entering this contract, they do not rely upon any previous representation, whether expressed or implied and whether written or oral or any inducement, understanding or agreement of any kind not included within the contract document and all prior negotiations, representations, agreements and understanding not included herein are hereby cancelled and the parties shall have no claim, rights in respect thereof and shall seize to have an effect upon entering into this Contract.
